COMMITTEE UPDATES

Program Committee (B. Burke & W. Charnock)

Currently the PC is talking about potential Keynote presentations and sorting out content for NANOG 64. There is a committee call next week to further develop the program. Peering changes are being spearheaded as adjusted by Tony with support from Will. Changes to the Peering Track, room set-up, content, etc., are an experiment, made based on feed-back from community in previous sessions. NANOG staff are spear-heading the Peering Personals.

All is going well in the CC. They have a few action items to work on. Randy and Stacy have volunteered to serve as mentors for Fellowship awardees. Randy has also volunteered to develop/update a page on the NANOG website that details other network organizations and how to connect with them.

Peering Personals Sponsorship

Outline for sponsorship, and programing of the session were reviewed. In a 90-minute session, people will sign-up to provide a peering personal update, NO SLIDES, walk-ups will be permitted if time allows. Time spent on personals updates will not be longer than 30 minutes. Tables will be assigned to people that sign-up to present a peering personal for further networking in the last 60 minutes of the session. Sponsorship is set at \$15,000 with a limit of 2 sponsors per conference. Two companies are on-board to sponsor at NANOG 64. This is a good start to a new session, and will revisit further down the road if growth is needed.
