I have over 15 years of experience in the Internet industry, covering educational, carrier and critical infrastructure organizations. I began my work with large networks at the University of Wisconsin/WiscNet, and progressed to subsequent

I have significant experience in highly technical design and operations roles, as well as in management roles that focus on the complex marriage between the technical and political/financial realities of a company. As such, I am well-equipped to deal with both the administrative challenges inherent in guiding NANOG as an organization, as well as the needs of the members and the industry that they are responsible for shaping.

Having served as a member of the NANOG Program Committee since 2010, and as a diamond corporate sponsor since the Newnog transition, I'm personally invested in the organization, and have a high degree of motivation to ensure its continued success and vitality.

2) Describe the relevance of your technical and professional experience to serve on the position you are interested in.

My career experience consists of a mix of technical and managerial roles, giving me subject matter expertise, as well as practical experience in running the administrative, budgetary and political aspects of an organization. 3) What Internet-related services do you or your current employer or organization provide?

Verisign operates the infrastructure for a portfolio of top-level domains that today include .com, .net, .tv, .edu, .gov, .jobs, .name and .cc, as well as two of the world's 13 Internet root DNS servers. Verisign's product suite also includes Distributed Denial of Service (DDoS) Protection Services, iDefense Security Intelligence Services and Managed DNS.
